

Scooter Giveaway Promotion

Official Rules

Promotional period begins on July 15th, 2016 at 12:00pm Pacific Time and ends on August 30th, 2016 at 11:00pm Pacific Time. All times referred to throughout these Rules are Pacific Standard Time. As used herein "Company" means Aristocrat Technologies, Inc. and all its parent, affiliated and subsidiary companies.

General Rules:

1. Participation is void where prohibited or restricted by law.
2. Must be at least 18 years of age to participate and the ultimate prize recipient must be at least 18 years of age.
3. This Promotion is subject to all applicable federal, state, and local laws and regulations, and all aspects of the Promotion are subject to the approval of appropriate regulatory authorities.
4. Participants agree to allow Company the unconditional use of their name and likeness for promotions/advertising and announcements without compensation, consideration, notice, review, or consent, where permitted. In addition, each Participant agrees that, as part of its own contest in connection with this Promotion, to include in such contest rules that Company may use the name and likeness of the player who receives the scooter for promotions/advertising and announcements without compensation, consideration, notice, review, or consent, where permitted.
5. Participants are responsible for payment of any and all taxes, licenses, registrations and other fees, as applicable.
6. Company reserves the right to change the rules of the Promotion times due to unforeseen or extenuating circumstances.
7. All decisions regarding the interpretation of rules, eligibility, etc. for this Promotion lie solely with Company whose decisions are final.
8. Company reserves the right to modify or cancel this Promotion at any time, for any reason, subject to any applicable regulatory approval, provided that such modification shall not, as of the date of such modification, materially alter or change any prize already awarded. Notice of any such modification is sufficient if emailed to Participant.
9. Company may disqualify any Participant from receiving any prize based upon fraud, dishonesty, violation of these rules or other misconduct whether or not related to this Promotion.
10. Company is not liable for injuries or losses arising or resulting from participation in the Promotion and is not liable for any acts or omissions by employees, whether negligent or willful, in the conduct of the Promotion and is not liable in the event of any equipment or software malfunction.
11. Company is not responsible for lost, late, mutilated, or illegible entries nor for electronic transmission errors or delays resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, hardware, software, or telephone failures of any kind, lost or unavailable connections, fraud, incomplete, garbled, or delayed computer transmissions, whether caused by Company, users, or by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the processing of submissions which may limit, restrict, or prevent a Participant's ability to participate in the Promotion.
12. If for any reason the Promotion is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of Company which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Promotion, Company reserves the right at its sole discretion to cancel, terminate, modify or suspend the Promotion.

13. Any attempt by any person to deliberately damage any program or to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws and should such an attempt be made, Company reserves the right to seek damages from any such person to the fullest extent of the law.
14. Prizes awarded are transferable by the prize winner to one individual who is at least 18 years of age.
15. By participating in this Promotion, Participants agree to the rules.
16. Company reserves the right to substitute prizes that have or have not been awarded as long as the value is substantially the same as the original prize offered in the event that the original prize becomes unavailable.
17. Company is not responsible for prizes that are lost or stolen in transit, or for prizes that are misaddressed.
18. As a condition of being awarded any prize, the Company may require a winner to execute and deliver to the Company a signed affidavit of eligibility, acceptance of these Rules, release of liability, and any other legal, regulatory, or tax-related documents.
19. **PRIZE COMES WITH NO WARRANTIES.** The prizes are scooters. Company expressly disclaims any and all warranties related to the prizes awarded including, but not limited to, any warranty of merchantability, infringement or fitness for a particular purpose.
20. **INDEMNIFICATION.** Company expressly disclaims any and all liability related to the prizes awarded. Participants shall defend from and against any and all claims, demands, actions, proceedings or suits (collectively "**Claims**") brought against Company related to the operation, design and/or performance of the prizes awarded pursuant to this Promotion, and in no event shall Participants be entitled to recover from Company any punitive damages, special damages or consequential damages or any other damages, and Participants shall indemnify and hold harmless Company from and against all losses, damages, expenses, costs (including, but not limited to, fees for attorneys and other professionals and costs of litigation) and liabilities arising out of or relating to any such Claims.
21. For avoidance of any doubt, Company does not grant, and nothing in these Rules shall be construed to or interpreted to grant, permission to Participants to use the Vespa name, trademark or likeness in advertising or promotional materials relating to this Promotion.
22. All issues and questions concerning these Rules, or the rights and obligations in connection with the Promotion, will be governed by, and construed in accordance with, the laws of the state of Nevada.

Promotion Specific Rules:

23. Subject to these Official Rules, this Promotion is open to all eligible casino customers of the Company who meet the entry requirements ("Customers").
24. Subject to these Official Rules, seven (7) winners will be drawn under this Promotion. Each winner will receive one scooter to display and give away to a player, as part of its own promotion ("Customer's Promotion"). Customer shall indemnify and hold harmless Company from and against all losses, damages, expenses, costs (including, but not limited to, fees for attorneys and other professionals and costs of litigation) and liabilities arising out of or relating to any claims, demands, actions, proceedings or suits brought against Company related to the operation, design, and/or performance of the prizes awarded pursuant to Customer's Promotion.
25. Entry Rules:
 - a. To qualify for a free entry into a drawing for a prize, Customer must either sign a lease order, or submit a conversion order (converting from single-site progressive to multi-site progressive is the only acceptable conversion order under this Promotion), for a four-pack of the Company's Multiverse MSP Big Bang Theory slot game (each, an "Order") by August 30, 2016 (the "Deadline"), which shall be installed by September 30, 2016.
 - b. Each Customer shall receive one entry per Order.
 - c. Each Customer shall be eligible to receive one prize only.

26. The winners will be selected by drawing from all eligible entries by Aristocrat staff on September 10th, 2016 and the winners will be notified individually by email (the "Prize Draw".) Winners must contact the Company within 5 calendar days from the date the notification is sent by the Company to claim each prize. Participants acknowledge that the result of the Prize Draw is final. Participants waive all right to challenge the result of the Prize Draw.
27. Odds of winning depend on the number of eligible entries received by the Deadline.
28. Prizes may not be redeemed for cash and no substitution is permitted. Company shall determine the nature of the prizes to be awarded to all Participants.
29. Within 180 days after claiming the prize, winners must hold a giveaway of the prize to a player. If a giveaway is not held within such time period, winner shall forfeit the prize. Company shall bear no responsibility for any costs or liability related to the subsequent giveaway or prize delivery.
